Investment Policy

The fund shall invest in the investment units of foreign equity funds and/or foreign equity ETFs which have investment policy to invest in securities or instruments of companies that contribute to social responsibility in 3 aspects: Environmental, Social and Governance (ESG) or companies with a measurable positive societal impact or companies that have an impact on the development of a sustainable global economy, on average in an accounting year, of not less than 80% of fund's NAV. The fund can diversify the investment in various regions around the world, or at certain times may have an emphasis on some countries, group of countries, regions and/or business groups. The management company may invest in foreign equity funds and/or foreign equity ETFs at least 2 funds in the proportion to each fund not exceeding 79% of net asset value of the fund. The investment proportion of each foreign equity fund and/or foreign equity ETF will depend on the discretion of the management company, investment conditions or investment situation expectation in each period. The fund may invest in derivatives for hedging purpose, depending on the discretion of the management company as appropriate to the circumstances of each moment. Currently, the fund will invest in derivatives for hedging foreign exchange rate risk about 90% of the foreign investment assets.

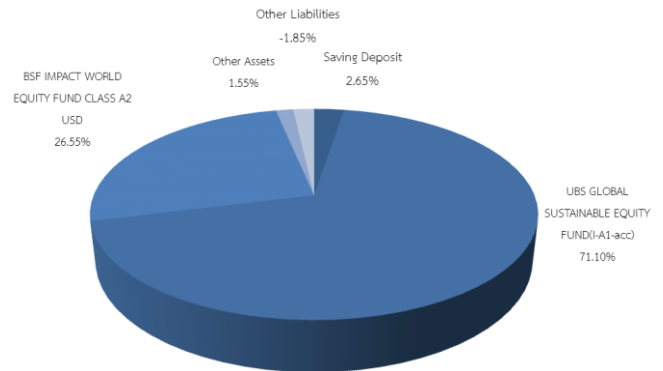

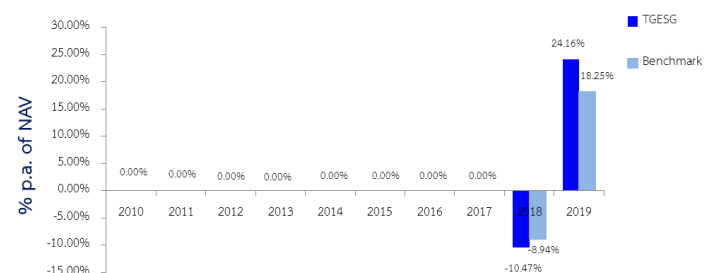
