Investment Policy

The fund shall invest at least 80% of its NAV in iShares EURO STOXX 50 UCITS ETF (Inc) (master fund), an Exchange Traded Fund listed and traded on Deutsche Börse, Bolsa, Germany. The master fund is managed by the BlackRock Asset Management Ireland Limited and aims to invest so far as possible and practicable in the equity securities (e.g. shares) that make up the benchmark index in order to reflect the return of the EURO STOXX 50 Index. In normal circumstance, the fund will not invest in derivatives for exchange rate risk hedging but the fund may invest in derivatives for hedging purpose upon fund manager's judgment in the future.

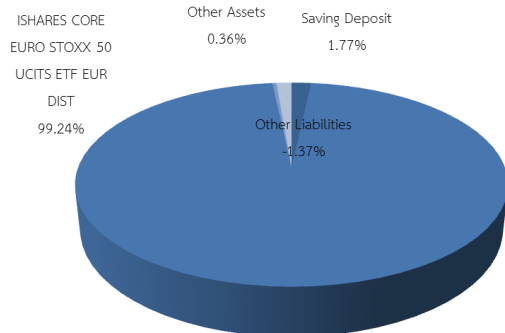

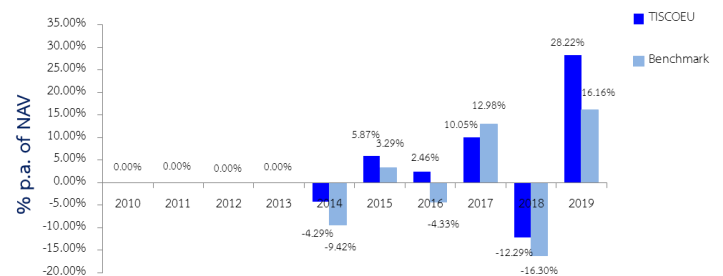
