The master fund is managed by Invesco Capital Management LLC and has an investment objective to track the investment results (before fees and expenses) of the FTSE China Incl A 25% Technology Capped Index. The FTSE China Incl A 25% Technology Capped Index is designed to represent the performance of the Large and Mid Cap Chinese technology industry.

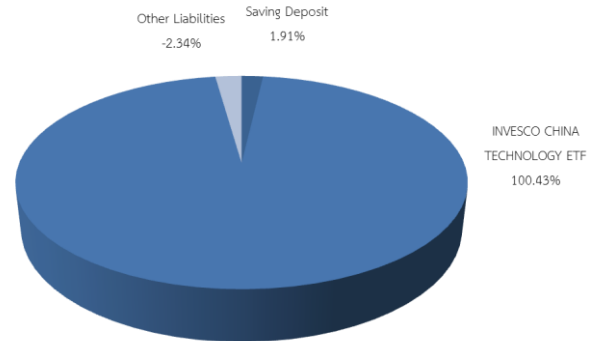

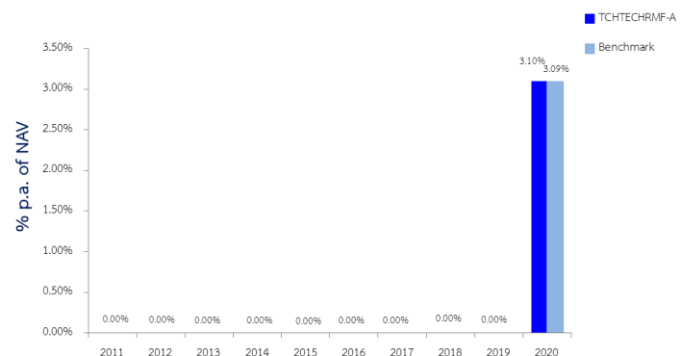
