Investment Policy

The fund shall invest at least 80% of its NAV in 20 first stocks that are ranked by market capitalization and are constituents of the SET50 Total Return Index. The proportion of each stock will be at the discretion of the management company depending on the circumstances of each moment. At the first investment date, the management company will invest in stocks that are constituents of the SET50 Total Return Index and have market capitalization at the previous day in the top 20. The management company will change the list of stocks and the investment proportion of each stock on a quarterly basis. The management company will consider the list of stocks that are constituents of the SET50 Total Return Index and have market capitalization at the last business of each quarter in order to select 20 first stocks for investing in the next quarter.

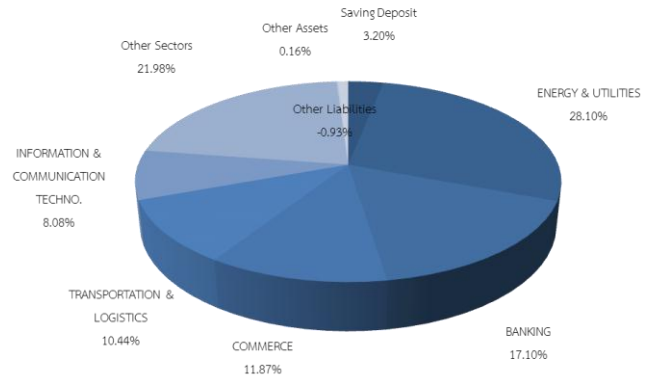

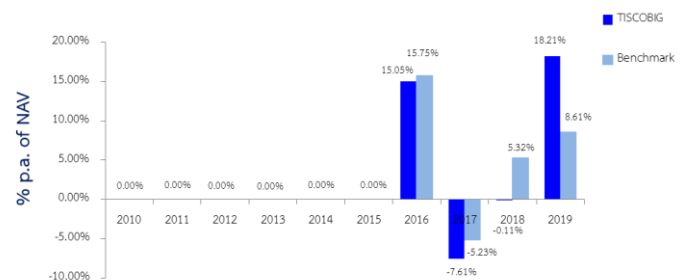
