- Global X China Clean Energy ETF's (the "Fund's") investment in equity securities is subject to general market risks, whose value may fluctuate due to various factors, such as changes in investment sentiment, political and economic conditions and issuer-specific factors.
- Many clean energy companies are involved in the development and commercialization of new technologies, which may be subject to delays resulting from budget constraints and technological difficulties. FDIs are susceptible to price fluctuations and higher volatility, and may have large bid and offer spreads and no active secondary markets.
