- Offers broad representation of the target sector across large-, medium-, and small-cap companies.

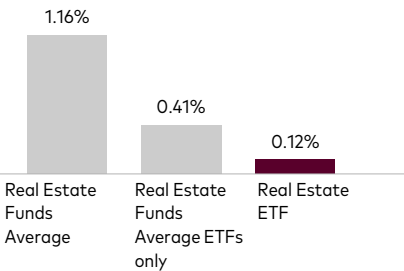
